The solenoid pinch valve provides a high closing force for its small package size, and the same size valve body accommodates tube sizes up to 10 mm in diameter. By considering fluid media, tube material and diameter, and the closing force needed to completely stop fluid flow, the valve can be customized for a variety of fluid control applications.






